### LETTER FROM THE GOVERNANCE BOARD ....

Fellow Congregants:

It has been a long time since we've been able to meet together in common cause; to engage with one another in trust and honesty and to seek out a future together that is both hopeful and faithful. We must embrace this future with a willingness to accept our emerging reality over the scant months and years to come.

In order for us to emerge from this period of intentional interim ministry with success, we must take steps to restore our self-governing capacities and to instill confidence that Bridge Street United Church has its house in order as a vital community of faith and a reliable partner with whom the UCC and other community partners can work, with both confidence and assurance.

Over the past few years, considerable time and effort have been devoted to developing both a strategic plan, as well as a behavioural covenant. It is the responsibility of the Governance Board to ensure that we hold ourselves accountable in accordance with the precepts that are embodied in those documents. Therefore, a number of consequences will ensue.

Firstly, we can no longer expect to enjoy unfettered access to all of our space in this church building, as we have grown accustomed to enjoy over the years. We cannot afford to sustain the costs of operating our church in this space without receiving the financial compensation from partners who are willing to share some of our space, and are prepared to pay for using it. We need to remain open to new opportunities to share our space with a variety of community partners.

Secondly, we cannot take a view of ourselves that imagines only a worshipping community of faith. We must live out our faith in meaningful ways that find resonance in our downtown core location. We must seek equilibrium; a state of balance that meets both the outreach and inreach needs of our entire community.

Thirdly, a new way of being church needs to be explored. We cannot persist in confining our identity and our scope of activity solely within the bounds of what has come to be known as Bridge Street United Church. We must recall the wisdom of Jesus' admonishment about putting "new wine" into "old wineskins".

Lastly, we must be vigilant about living into our "Commitment for Respectful Living", a behavioural covenant adopted by the congregation. However, we must move beyond merely establishing this framework. We must actively create safe space and brave space that provides an equity of voice to everyone; to be able to express ourselves in a respectful and non-intimidating manner, without fear of recrimination or judgment. In short, we must provide 'space for grace'. We must create very specific mechanisms and processes that enable us to resolve conflict within our church, to call out inappropriate behaviours, and to allow reconciliation and healing to take place. Consequently, the board has authorized the Transition Team to pursue a facilitated process of restorative conversation from an external service provider with expertise in this area. This is necessary to be completed before difficult issues can be resolved within our church whenever they might arise.

As we enter into the seasons of Advent and Christmas, may we do so with the joyful knowledge that worship is returning to a more satisfying, rewarding and, above all, safe state.

On behalf of the Board, please accept our fondest wishes for an enriching time of reconnection with family and friends after the depths of this Covid pandemic.
